## WITNESSETH:

WHEREAS, as an incentive to it's citizens, LIBERTY TOWNSHIP intends to reimburse partially RESIDENT within it's corporate limits for the costs of VOLUNTEER pumping of septic tank; and

WHEREAS RESIDENT in compliance with the LIBERTY TOWNSHIP Sewage Management Program voluntarily agrees to have their septic tank pumped under regulations established by LIBERTY TOWNSHIP.

NOW THEREFORE, the parties hereto, intending to be legally bound hereby agrees as follows:

- 1. RESIDENT shall within 60 days of the signing of this agreement have the septic tank on the property of RESIDENT voluntarily pumped by a reputable septic pumping service.
  - 2. RESIDENT further agrees to have the septic tank pumped at reasonable intervals designated by LIBERTY TOWNSHIP of not more than (4) four years.
  - 3. In consideration of said agreement by RESIDENT, LIBERTY TOWNSHIP shall reimburse the costs of said pumping in an amount to be set by resolution of the Board of Supervisors from time to time.
  - 4. RESIDENT shall obtain from LIBERTY TOWNSHIP the proper form (Sewage Maintenance Reimbursement Form) each time the sewage tank is to be pumped.
  - 5. In order to seek reimbursement of the amount established by LIBERTY TOWNSHIP, RESIDENT shall return, within 30 days, the completed form (Sewage Maintenance Reimbursement Form).
  - 6. Upon tendering said form LIBERTY TOWNSHIP shall cause a check to be issued for the said reimbursable amount of the cost of pumping within 30 days.
  - 7. LIBERTY TOWNSHIP will then send out a reminder to the RESIDENT when it is time for the next pumping.
